NOTICE NO. A. 5504/2017

It is hereby informed to all the retired Judicial Officers in the cadre of District Judge, Ad-hoc District Judge, and Senior Civil Judge, that the High Court of Bombay has commenced the Selection Process for filling up 14 temporary additional posts of District Judge, from retired District Judges and 4 temporary additional posts of Senior Civil Judge, and Additional Chief Judicial Magistrate / Metropolitan Magistrate from retired Ad-hoc District Judges / Senior Civil Judges.

The temporary additional courts in the cadre of District Judge are tentatively proposed to be established at places Viz. 1) Thane (MACT), Thane, 2) Nagpur (MACT), Nagpur, 3) Vaduj, Satara, 4) Pandharpur, Solapur, 5) Achalpur, Amravati, 6) Mangaon, Raigad-Alibag, 7) Aurangabad, 8) Karad, Satara, 9) Nanded, 10) Parbhani, 11) Nagpur, 12) Barshi, Solapur, 13) Niphad, Nashik, and, 14) Vasai, Thane. Whereas temporary additional posts in the cadre of Senior Civil Judge and Additional Chief Judicial Magistrate / Metropolitan Magistrate are proposed to be established at places Viz. 1) C.M.M., Mumbai, 2) Pune, 3) Nagpur and 4) Nashik.

The retired Judicial Officers from the cadre of District Judge shall be considered for the post of District Judge whereas retired Judicial Officers from the cadre of Ad-hoc District Judge and Senior Civil Judge shall be considered for the post of Senior Civil Judge & Additional Chief Judicial Magistrate / Metropolitan Magistrate.

The retired Judicial Officers not more than the age of 63 years as on 31.03.2017 having no assignment post retirement shall be considered. The retired Judicial Officers who have taken voluntary retirement and those who are compulsorily retired or dismissed shall not be considered.

Please find annexed herewith prescribed proforma. The applicant shall send the willingness / information in the prescribed proforma to the office of Hon'ble Registrar General, High Court of Bombay, Fort, Mumbai - 400 032 on or before 31.03.2017. The applicant shall have to submit Medical Fitness Certificate of Civil Hospital along with the willingness. The application without such Medical Fitness Certificate shall not be considered. The envelope containing willingness / information in prescribed proforma and medical fitness certificate should be superscribed with the words **“Application for the temporary additional posts (for retired Judicial Officers) under 14th Finance Commission.”**
