(Recruitment Process – 2017)

- 1) The documents and testimonials as per Clause No. 4 of the advertisement dated 04.12.2017 for the post of Judge, Family Court, by nomination, under 14th Finance Commission :-
 - i) his/her age as on the last date of submission of online application e.g. S.S.C. Board Certificate or Secondary School Certificate or Certificate of Age, Nationality and Domicile issued by the competent authority.
 - ii) he/she has held a Judicial Office for 7 years in India or the office of a Member of a Tribunal or any post under the Union or a State requiring special knowledge of law.
 - iii) his/her standing as Legal Practitioner 7 years in Court (original).
 - iv) that he/she is of good moral character from two respectable persons (original).
 - v) that he/she is certified to have sufficient knowledge of Marathi to enable him/her to speak, read, write and translate into English and vice versa (original).
 - vi) other certificates in support of the claim to have one or the other qualifications as referred in Clause No. 2 of the advertisement.
 - vii) the copy of the marksheet and degree certificate of LL.B. Examination, and other graduation and post graduation examination.
 - viii) the copy of Sanad issued by Bar Council (for Advocate).
 - ix) income tax returns, if any, in respect of the immediate preceding three years/pan card.
