

**PROCEDURE TO GET CASE STATUS/ CC APPLICATION STATUS USING SMS**

*Please Compose the SMS as follows :*

The text indicated following of the first two words (i.e BHC BO) of the SMS text above has to be substituted as follows:

*xx : To be substituted by Case Type Code for Eg. WP- Writ Petition, FA – First Appeal etc.*

*yy : To be substituted by Case Number eg. 123, 458*

*zzzz : To be substituted by Case Year eg. 2009,2014 etc.*

*Please note that the items mentioned above should be interspersed with single blank space in between.*

*An example of a SMS Composed for getting Case Status would be :*

*For Original Side Writ Petition 1 of 2014 - **BHC BO WP 1 2014***

As an alternate option to above structure a query can be mad using following method

**bhc CIN**

where CIN is the 14 digit Case Identification Number , unique for each case .(Users can visit following web page link to see their case CIN <http://bombayhighcourt.nic.in/cin.php>)

***After composing SMS , send it to mobile no. 07738299899, a reply SMS would be received instantly regarding the status of the case.***

**SMS BASED CERTIFIED COPY STATUS ENQUIRY**

*In Addition the SMS based Case Status System , Bombay High Court is happy to announce SMS based Status of Certified Copy Applications.*

To get status of Certified Copy Application compose a SMS as follows :-

**BHC CC BOU nn yyyy** (For Bombay High Court Original Side CC Applications)

**BHC CC BAO nn yyyy** (For Bombay High Court Appellate Side (Ordinary) CC Applications)

**BHC CC BAU nn yyyy** (For Bombay High Court Appellate Side (Urgent) CC Applications)

wherein 'nn' is to be replaced with the CC Application Number i.e 1,9,13,678 etc.

and 'yyyy' is to be replaced with four digit year of CC Application i.e. 2013,2014 etc.

Please note that item mentioned above should be interspersed with single blank space in between.

An example of query framed to get information of O. S. CC Application No. 67 of 2014 would be BHC CC BOU 67 2014

After composing SMS , send it to mobile no. **07738299899**, a reply SMS would be received instantly regarding the status of CC Application.
